POSITION: Registered Clinical Officer III

Number of Posts: Six (6)

Terms of Service: Three (3) Years Contract

Remuneration: Consolidated Package of Ksh.50, 000

Requirements for Appointment

For appointment to this grade, a candidate must have a:-

(i) Diploma in Clinical Medicine and Surgery or Clinical Medicine and Community Health from a recognized institution; and

(ii) Certificate of Registration by Clinical Officers' Council

Duties and Responsibilities:-

This is an entry grade into this cadre and an officer at this level will work under guidance of a senior officer. Specific duties and responsibilities at this level will include:

- (i) taking history, examining, diagnosing and treating patients' common ailments at an outpatient or inpatient health facility;
- (ii) implementing Community Health Care activities in liaison with other health workers;
- (iii) quiding and counseling patients, clients and staff on health issues;
- (iv) sensitizing patients and clients on preventive and promotive health;
- (v) carrying out minor surgical procedures as per training and skill;
- (vi) collecting and compiling clinical data; and
- (vii) Referring patients and clients to appropriate health facilities.

POSITION: Registered Nurse III Number of Posts: Fifteen (15)

Terms of Service: Three (3) Years Contract

Remuneration: Consolidated Package of Ksh.50, 000

Requirements for Appointment

For appointment to this grade, a candidate must have: -

- (i) Diploma in any of the following disciplines: Kenya Registered Community Health Nursing, Kenya Registered Nursing, Kenya Registered Midwifery, Kenya Registered Nursing/Midwifery or Kenya Registered Nursing/Mental Health and Psychiatry from a recognized institution;
- (ii) Registration Certificate issued by the Nursing Council of Kenya; and
- (iii) Valid practicing license from the Nursing Council of Kenya;

Duties and Responsibilities

This is an entry and training grade for this cadre. An officer at this level will work under the guidance of a senior officer. Duties and responsibilities at this level will entail:

- assessing, planning, implementing nursing interventions and evaluating patient's outcomes;
- (ii) providing appropriate healthcare services including Integrated Management of Childhood Illnesses (IMCI), Immunization, PMTCT, Ante-natal care and delivery, providing health education and counselling to patients/clients and community on identified health needs;
- (iii) referring patients and clients appropriately;
- (iv) facilitating patients' admission and initiating discharge plans;
- (v) maintaining records on patients/clients health condition and care;
- (vi) Ensuring a tidy and safe clinical environment; and
- (vii) Collecting and compiling data.

POSITION: Pharmaceutical Technologist III

Number of Posts: Six (6)

Terms of Service: Three (3) Years Contract

Remuneration: Consolidated Package of Ksh.50, 000

Requirements for Appointment

For appointment to this grade, a candidate must have a: -

(i) Diploma in Pharmaceutical Technology from a recognized training institution;

(ii) Certificate of Registration as a Pharmaceutical Technologist by the Pharmacy and Poisons Board;

(iii) Valid practicing license from Pharmacy and Poisons Board.

Duties and Responsibilities

This is an entry and training grade for this cadre. At this level, an officer is expected to be guided to provide pharmaceutical services in a National and County hospitals. The officer will also be expected to work in pharmaceutical services in a district hospital in the absence of a pharmacist or be in the line assistant to the pharmacist. Duties and responsibilities will include:

- (i) compounding and dispensing medicine, supervision of Pharmaceutical Technologists and other staff under him;
- (ii) an officer who has been trained in Pharmaceutical analysis and has successfully completed such a course may be assigned drugs quality control duties;
- (iii) In a medical training institution, work involves training, counselling and guiding students; and
- (iv) Participating in curriculum development, implementation and evaluation of training programmes, student recruitment and induction.

Requirements for Appointment

For appointment to this grade, an officer must have a

- (i) Diploma in Medical Laboratory Technology from a recognized institution;
- (ii) Registration Certificate issued by the Medical Laboratory Technicians and Technologist Board of Kenya;
- (iii) Valid practicing license from the Medical Laboratory Technicians and Technologist Board of Kenya.

Duties and Responsibilities:

Duties and responsibilities at this level will entail:-

- (i) Coordinating provision of laboratory services in a number of units/sections;
- (ii) Preparing work plans and programs for laboratory activities;
- (iii) Submitting samples to reference laboratories and institutes for further analysis;
- (iv) Preparing laboratory manuals and quality specifications;
- (v) Supervising safe laboratory waste disposal;
- (vi) Carrying out efficacy tests; Initiating requisition proposals and undertaking technical evaluation for laboratory supplies/equipment; and
- (vii) Formulating technical laboratory standards.

Requirements for Appointment

For appointment to this grade, a candidate must have a:-

- (i) Kenya Certificate of Secondary Education (KCSE) mean grade C (plain) in English/Kiswahili, Biology/ Biological Sciences or Physics/ Physical Sciences and C- (minus) in Mathematics;
- (ii) Diploma in any of the following fields; Diagnostic Radiography/Medical Imaging Sciences, Ultrasound, Computerized Tomography, Magnetic Resonance Imaging, Mammography, Nuclear Medicine, Radiation Therapy and Digital Medical imaging equipment or its equivalent from a recognized institution; and
- (iii) Proof of registration with the relevant professional body

Duties and Responsibilities

This is an entry and training grade for Radiographers cadre. An officer at this level will work under the supervision and guidance of an experienced officer.

Specific duties will include:

- (i) Providing radiographic services to the patients;
- (ii) processing, verifying and maintaining information relating to patients; and
- (iii) ordering and maintaining records of radiographic and photographic supplies.

Requirements for Appointment

For appointment to this grade, a candidate must have a Certificate in any of the following disciplines: Community Health, or Community Health and Development from a recognized institution.

Duties and Responsibilities:

Duties and responsibilities at this level will include:

- (i) collect and collate the Community Health House Hold Data to be uploaded to Kenya Health Information System;
- (ii) supervise the Community Health Volunteers (CHVs) when collecting data in the households; train Community Health Volunteers (CHVs) on the thirteen Community Health Volunteers Modules;
- (iii) conduct Community Health dialogues and Community Health action days; and
- (iv) Give technical support to Community Health Committees.

POSITION: Enrolled Community Health Nurse

Number of Posts: Ten (10)

Terms of Service: Three (3) Years Contract

Remuneration: Consolidated Package of Ksh.40, 000

Requirements for Appointment

For appointment to this grade, a candidate must have: -

- (i) Certificate in any of the following disciplines: Kenya Enrolled Nurse, Kenya Enrolled Community Health Nurse, Kenya Enrolled Midwife, Kenya Enrolled Psychiatric Nurse or Enrolled Nurse/Midwife from a recognized institution;
- (ii) an enrolment Certificate issued by the Nursing Council of Kenya; and
- (iii) a valid practicing license from the Nursing Council of Kenya

Duties and Responsibilities:-

This is an entry and training grade for this cadre. An officer at this level will work under the quidance and supervision of a senior officer. Duties and responsibilities at this level will include:-

- (i) assessing patients and clients and establishing health care needs;
- (ii) planning and implementing nursing care interventions based on patients'/clients' health needs;
- (iii) providing appropriate healthcare service, including immunization, ante-natal care, delivery, referring patients and clients appropriately;
- (iv) evaluating healthcare outcomes on patients/clients preparing individualized reports;
- (v) making appropriate discharge plan for patients;
- (vi) conducting assessment of school health needs;
- (vii) planning, implementing interventions and preparing periodic reports;
- (viii) maintaining records on patients/clients personal and health condition/care;
- (ix) ensuring a tidy and safe clinical environment;
- (x) ensuring safe custody for in-patients belongings;
- (xi) Conducting home visits, following up discharged patients/clients and providing continuity of care; and treating minor ailments.

POSITION: Assistant Health Records and Information Management Officer III

Number of Posts: Five (5)

Terms of Service: Three (3) Years Contract

Remuneration: Consolidated Package of Ksh.50, 000

Requirements for Appointment

For appointment to this grade, a candidate must have:

- (i) Diploma in Health Records and Information Technology from a recognized institution; and
- (ii) Certificate of Registration from Association of Medical Records Officers' Kenya (AMRO-K).

Duties and Responsibilities:

Duties and responsibilities at this level will entail:

- (i) receiving and documenting patients at hospital reception;
- (ii) registering and booking appointment for patients to clinics and consultants;
- (iii) storing and retrieving medical records documents;
- (iv) preparing clinics;
- (v) updating bed bureau;
- (vi) editing of patient case records;
- (vii) gathering data from different sources;
- (viii) capturing data from service points;
- (ix) maintaining record safety and confidentiality;
- (x) storing and retrieving medical records;
- (xi) balancing daily bed returns;
- (xii) creating and maintaining master index;
- (xiii) updating patient master index; directing patients to relevant clinics;
- (xiv) scheduling of patients to the consultants and specialty clinics; and
- (xv) Assigning codes to diseases and surgical procedures according to the International Classification of Diseases and Procedures in Medicine.

Requirements for Appointment

For appointment to this grade, a candidate must have: -

- (i) Diploma in Community Nutrition, Clinical Nutrition or Nutrition and Dietetics from a recognized training institution; and
- (iii) Registration by the Council of the Institute of Nutritionists and Dieticians (CIND)

Duties and Responsibilities:

Duties and responsibilities at this level will include:

- (i) implementing nutrition programmes; providing nutrition services in health care facilities; conducting nutrition assessments;
- (ii) collecting and compiling nutrition data;
- (iii) providing nutrition health education and demonstrations;
- (iv) counseling of patients with specific nutritional needs;
- (v) monitoring preparation of therapeutic feeds;
- (vi) implementing outpatient and inpatient supplementary and therapeutic feeding programmes; promoting maternal, infant and young children feeding programmes; and
- (vii) Providing micronutrient supplementation.

- (ii) Registration by the Council of the Institute of Nutritionists and Dieticians (CIND).

Duties and Responsibilities:

Duties and responsibilities at this level will include:

- (i) assessing community nutrition needs; following-up on discharge cases from hospitals;
- (ii) screening for deficiency diseases and chronic
- (iii) illnesses related to nutrition in a community setting and referring them to various existing programs;
- (iv) collecting data on nutrition and dietetics;
- (v) promoting baby friendly community initiatives;
- (vi) conducting community growth, monitoring and promotion activities;
- (vii) assisting in community interventions on diet and lifestyle disease prevention and control;
- (viii) promoting optimal infant and young child feeding programmes;
- (ix) assisting in running out patient supplementary feeding programs and outpatient therapeutic feeding programs;
- (x) Following up and counseling of patients in home-based disease management; and
- (xi) Carrying out nutrition health education.

Duties and Responsibilities

Duties and responsibilities at this level will entail;

- (i) maintaining records and data relating to patients;
- (ii) collecting data for operational research;
- (iii) Sensitizing the community on occupational therapy issues; and preparing periodic reports.

- (iii) participating in management of minor orthopedic and trauma cases in emergencies and accidents;
- (iv) sensitizing the community on orthopedic and trauma conditions; and
- (v) Counselling patients/clients on issues regarding orthopedic and trauma.
