#### **Main duties and responsibilities:**

- Ensure good commodity management practices for HIV/TB commodities.
- Ensure 100% utilization of WebADT for dispensing of ARVs, managing HIV/TB commodity stock, generating of monthly consumption reports (FMAPS/FCDRR), generating patient level reports.
- Pharmacovigilance monitoring and reporting via PPB platform.
- Play a key role in CCC CQI team.
- Ensure accurate and timely reporting of HIV/TB commodities through DHIS2 platform.
- Play a key role in CCC MDT discussions.
- Spearhead CMEs on Pharmacovigilance monitoring and reporting, WebADT use and Rational use of HIV/TB drugs.
- Ensure availability and use of relevant Pharmacy SOPs including medication use counselling checklist, good storage practices, good inventory management, good dispensing practices and expiry tracking chart.
- Support redistribution of short expiry HIV/TB commodities before expiry.
- Participate in facility monthly Performance Review Meetings.
