BOMET COUNTY ALCOHOLIC BEVERAGES CONTROL AGENCY APPEALS BOARD

The Bomet County Alcoholic Beverages Control Agency (BOCABCA) is a body corporate established under **Section 4** of the **Bomet County Alcoholic Beverage Control Act, 2021** to regulate the production, sale and consumption of alcoholic beverages and for connected purposes. **Section 12 Subsection 2(c)** of the Act further establishes the **County Alcoholic Beverages Appeals Board** to review on appeal decisions made by the Sub-County Alcoholic Beverages Control Committee.

Pursuant to this, the County Government of Bomet invites applicants to fill the positions of **three (3) Committee Members** of the Appeals Board.

Requirements for Appointment

- a) At least a Bachelor's degree in any of the following fields: Physical Planning, Environmental Science, Public Health, Law, Security, Public Affairs or Social Work or its equivalent from a university recognized in Kenya;
- b) Citizen of Kenya;
- c) Ordinarily a resident in the county;
- d) Satisfy the requirement of leadership and integrity in Chapter Six of the Constitution of Kenya, 2010

Term of Office

- i. Three (3) years, **on a part-time basis**.
- ii. Remuneration and benefits as set out by Salaries and Remuneration Commission (SRC)

Application Guidelines


