# REQUIREMENTS FOR APPOINTMENT

For appointment, the applicant should meet the following requirements:

- i. Satisfy the provisions of Chapter Six of the Constitution of Kenya, 2010.
- ii. Not be a State or Public Officer
- iii. Possess a minimum qualification of a Bachelor's Degree from a recognized University in Kenya.
- iv. Have a working experience of not less than five (5) years in their respective profession. v. Has not at any time within the preceding five (5) years, held office, or vied for elections

  - a) A Member of Parliament or of a County Assembly.b) A Member of the governing body of a Political Party.
  - c) A candidate for election as a Member of Parliament or of a County Assembly. or d) A holder of an office in any political organization that sponsors or otherwise supports,
  - or has at any time sponsored or otherwise supported, a candidate for election as a Member of Parliament or of a County Assembly.
- iii. Demonstrated clear understanding of National and County Government Goals, Policies and Development Objectives including Values and Principles of Governance, as well as demonstrated an appreciation of the diversity within the County.

  iv. Have thorough knowledge of the structural, legislative and regulatory framework of the
- Public Service.
- v. Demonstrate flexibility and adaptability with the capacity to work under pressure to meet strict timelines.
