## **BACKGROUND SUMMARY**

**Kakuyuni FCS Ltd** received a grant from Machakos County Government through the National Agricultural Value Chain Development Project (NAVCDP) for the e-voucher subsidy-based vaccination campaign against Foot and Mouth Disease. The Programme will entail identification, digital registration through muzzle technology and send to KIAMIS (National Farmers Digital register). **Kakuyuni FCS Ltd** therefore, invites applications from qualified animal service providers to enhance animal health, productivity and market access for its farmers.

The selected qualified individuals will support our farmers to identify, digitally register and vaccinate animals through e-voucher subsidy platform against Foot and Mouth Disease. The registered animals will later be legible for e-Voucher subsidy services and linked to the animal health service providers (AHSPs).

This programme will offer employment opportunities to Veterinary Surgeons (VS) and Veterinary Paraprofessionals (VPPs) by attaching them to the Farmer producer organizations / Cooperatives. The e-voucher system will ensure efficient service delivery, transparent and accountable transactions. The



Veterinary surgeons will be based at FPO while the Veterinary paraprofessionals will be at zonal level.

## **OBJECTIVES**

1. To enhance livestock health and productivity across Kenya
2. To prevent and control outbreaks of FMD
3. To strengthen Animal Health Service delivery through digital platforms
4. To enhance traceability of livestock and livestock Products

## **Key Responsibilities**

1. Administer FMD vaccines to targeted livestock populations
2. Sensitize farmers on the digital livestock registration and its benefits thereafter
3. Record and report vaccination data via the e-voucher system
4. Registration of animals through the digital platform
5. Effectively engage with livestock owners and local stakeholders
6. Ensure cold chain and vaccine integrity throughout the campaign period
7. Target animals in cattle, sheep and goats where applicable

## **Who Should Apply**

Licensed Veterinarians and Veterinary Para-professionals who are;

1. Registered, retained and therefore eligible to practice as per the Kenya Veterinary Board (KVB)
2. Willing to work in a rural set up amongst farmers
3. Familiar with digital tools leveraging on mobile technology communication
4. Available for deployment between November 2025 February 2026
